- 📌 All artwork must be ready to be attached to the wall with pushpins.
- 📌 Works should **not exceed 36 inches** (90 cm) in any direction and must be able to be displayed with pushpins only. No framed or matted works will be accepted.
- 📌 Work will be displayed on a **first-come first-served** basis. When the exhibit has reached capacity, additional works will not be accepted.
- 📌 Artists may include up to **three works** of art in the Pushpin Show. Please list each work on the entry form.
- 📌 Avant Garde reserves the **right to refuse** to display artworks deemed inappropriate or unsafe.
